#### NEW COMPANY

- Submit estimate

= Within first 3 months of operation (Form CP 204)

- Payment due - Payment date = 6th month of the basis period = Before / on 15th of every month

(Form CP 207)

- Revised estimate = In the 6th and 9th month of the basis period (Form CP 204A)

#### EXISTING COMPANY

- Submit estimate

= 30 days prior to the commencement of the basis period (Form CP 204) = 2nd month of the basis period

- Payment due - Payment date

- Revised estimate = In the 6th and 9th month of the basis period (Form CP 204A)

# **INSTALLMENT PAYMENT BY INDIVIDUAL**

#### OTHER THAN EMPLOYMENT (CP500)

- 6 installments will be issued by LHDNM
- Payment beginning March
- Installment must be paid within 30 days
- Apply for revision of the estimated tax before 30 June (if necessary)

#### **EMPLOYMENT (MTD)**

- Tax deduction based on MTD Method
- Pay before / on the 15th of every month (CP39)
