### 1. 25 FEBRUARY 2021 : THE DEADLINE FOR FILLING AND SUBMITTING e-DATA PRAISI FOR THE YEAR 2021

e-Data Praisi is a platform that allows employers to upload their employees' income information online, using the C.P.8D format. For Year 2020, C.P.8D is accessible via this link:

### 2. FORM EA / FORM EC YEAR 2020

Pursuant to the provisions of Subsection 83 (1A) of the Income Tax Act 1967 (ITA 1967), Form CP8A (Form EA) / CP8C (Form EC) must firstly be prepared by the employer and then submitted to employees on or before the 28th February of every year, so that the employees are able to complete their Return Forms within the stipulated time frame.

The deadline for preparing and submitting the Form EA/Form EC to the employees, is on or before the 28th February 2021.

### 3. THE 2021 e-FILING SEASON IS ABOUT TO BEGIN!

The e-Filing season begins on the 1st of March, every year, and it is a long-awaited day for the taxpayers, as it allows them to start fulfilling their responsibilities to the nation.

Please ensure that you have checked and are aware of the following steps before using the e-Filing system:

#### A. Not Registered As An e-Filing User

#### B. Have Registered, But Forgot Password / Blocked From e-Filing

ii. If your mobile number is registered with IRBM, please send "HASILEF <space> IND < space > <Identification No>" to 38888, to obtain the Temporary Activation Code via SMS.

### 4. THE REAL PROPERTY GAINS TAX (RPGT) RETURN FORM FOR YEAR OF ASSESSMENT (YA) 2021

For the disposals and acquisitions of assets which are subjected to the RPGT Act 1976 before Assessment Year 2021, you may use the RPGT Return Forms of Assessment Year 2020 and prior years, to declare the RPGT.
